Central Bureau of Weights and Measures Notification

Re: The Mass Tertiary Standards of one milligram up to twenty kilogram under the Weights and Measures Act B.E. 2542

B.E. 2558

Accordingly it is appropriate to provide the Mass Tertiary Standards of one milligram up to twenty kilogram for effectively calibrating weighing instruments used in trade, or providing weighing services, or weighing instruments used in compensation, tax, and fee calculation.

By virtue of Section 6 and Section 15 under the Weights and Measures Act B.E. 2542, therefore, Director General of Department of Internal Trade hereby issues the Notification as follows.

Clause 1 This Notification shall come into force on the following day of publication.

Clause 2 The class F1 and F2 stainless steel weights of one milligram up to twenty kilogram prescribed by the International Organization of Legal Metrology under the International Recommendation OIML R 111-1 belong to Central Bureau of Weights and Measures, Regional verification center, and Weights and Measures Branch Bureau of Department of Internal Trade, Ministry of Commerce are the Mass Tertiary Standards of one milligram up to twenty kilogram under the Weights and Measures Act B.E. 2542.

Clause 3 The class F1 and F2 stainless steel disc weights of one kilogram, two kilogram, three kilogram, four kilogram, and five kilogram, total of five pieces, prescribed by the International Organization of Legal Metrology under the International Recommendation OIML R 111-1 belong to Central Bureau of Weights and Measures, Regional verification center, and Weights and Measures Branch Bureau of Department of

Internal Trade, Ministry of Commerce are the Mass Tertiary Standards under the Weights and Measures Act B.E. 2542.

Clause 4 The class M1, M2, and M3 stainless steel stack weights of ten gram, twenty gram (two pieces), fifty gram, one hundred gram (two pieces), two hundred gram, five hundred gram, and one kilogram (three pieces), total of 11 pieces, prescribed by the International Organization of Legal Metrology under the International Recommendation OIML R 111-1 belong to Central Bureau of Weights and Measures, Regional verification center, and Weights and Measures Branch Bureau of Department of Internal Trade, Ministry of Commerce are the Mass Tertiary Standards under the Weights and Measures Act B.E. 2542.

Clause 5 The class M1, M2, and M3 cast iron weights of one kilogram, two kilogram, five kilogram, ten kilogram, and twenty kilogram, prescribed by the International Organization of Legal Metrology under the International Recommendation OIML R 111-1 belong to Central Bureau of Weights and Measures, Regional verification center, and Weights and Measures Branch Bureau of Department of Internal Trade, Ministry of Commerce are the Mass Tertiary Standards under the Weights and Measures Act B.E. 2542.

Clause 6 The Mass Tertiary Standards under Clause 2, Clause 3, Clause 4, and Clause 5 shall be calibrated by the Mass Secondary Standards of one milligram up to twenty kilogram every 3 years.
