Notification of the Office of the Central Committee on the Price of Goods and Services
No. 34, B.E. 2564 (2021)

Regarding Repeal of the Notification of the Office of the Central Committee on the Price of Goods and Services as regards Display of Purchase Price of Agricultural Products, namely Tomatoes, Cabbages, Pumpkins or Other Types of Vegetables

Whereas the Office of the Central Committee on the Price of Goods and Services already issued the Notification of the Office of the Central Committee on the Price of Goods and Services No. 29, B.E. 2563 (2020) regarding Display of Purchase Price of Agricultural Products, namely Tomatoes, Cabbages, Pumpkins or Other Types of Vegetables dated 7th October B.E. 2563 (2020), prescribing that the purchasers of the agricultural products, namely tomatoes, cabbages, pumpkins or other types of vegetables for production or distribution shall display the names of the products and the purchase prices together with the details of the kind, type, quality, class or impurity of the products at the place of purchase, a nearby area or a vehicle which is used for the purchase in order that agriculturists shall have a chance to make a comparison of the purchase prices of the agricultural products before making their decisions to sell the products and there shall be the prevention of taking advantage of opportunity in terms of the purchase prices in an unfair manner from the agriculturists.

Whereas the Central Committee on the Price of Goods and Services, by virtue of Section 28 of the Price of Goods and Services Act, B.E. 2542 (1999), has issued the Notification of the Central Committee on the Price of Goods and Services No. 62, B.E. 2564 (2021) regarding Display of Purchase Price of Agricultural Goods dated 1st July B.E. 2564 (2021) by adding the item of the agricultural products, namely tomatoes, cabbages, pumpkins or other types of vegetables in the List as attached to the aforesaid Notification and prescribing that the business operators who purchase such agricultural products for production or distribution shall display the names of the products and the purchase prices at the place of purchase or a nearby area to the place of purchase. In order to avoid a repetition in compliance with the law by the aforesaid business operators, the Office of the Central Committee on the Price of Goods and Services therefore issues this Notification to repeal the Notification of the Office of the Central Committee on the Price of Goods and Services No. 29, B.E. 2563 (2020) regarding Display of Purchase Price of Agricultural Products, namely Tomatoes, Cabbages, Pumpkins or Other Types of Vegetables dated 7th October B.E. 2563 (2020).
