

## NOTIFICATION OF THE CENTRAL BUREAU OF WEIGHTS AND MEASURES

### RE: PRESCRIPTION OF THE FORM OF VERIFICATION CERTIFICATE

---

To ensure that orderly and correctly issuance of verification certificate for a weighing and measuring instrument verified under the Weights and Measures Act B.E. 2542 as amended:

By virtue of the provisions of section 6(3) (5) of the Weights and Measures Act B.E. 2542 and section 30 of the Weights and Measures Act B.E. 2542 as amended by the Weights and Measures Act (No. 3) B.E. 2557, the Director-General of the Department of Internal hereby issues the Notification as follows:

**Clause 1.** This Notification shall come into force upon the expiration of ninety days from the date of its publication in the Government Gazette.

**Clause 2.** In regard to providing verification of a weighing and measuring instrument, a competent official shall issue a verification certificate for every weighing and measuring instrument except for weight.

**Clause 3.** Verification certification to verify a weighing and measuring instrument shall be in accordance with the form annexed to this Notification as follows:

(1) Form of verification certificate issued by a competent official (form Chor Wor 3001);

(2) Form of verification certificate issued by a license holder under section 41 of the Weights and Measures Act B.E. 2542 (form Chor Wor 3002);

(3) Form of verification certificate to affix issued by a competent official (form Chor Wor 3003) (circle shape);

(4) Form of verification certificate to affix issued by a license holder under section 41 of the Weights and Measures Act B.E. 2542 (form Chor Wor 3004) (circle shape);

(5) Form of verification certificate to affix issued by a competent official (form Chor Wor 3005) (square shape);

(6) Form of verification certificate to affix issued by a license holder under section 41 of the Weights and Measures Act B.E. 2542 (form Chor Wor 3006) (square shape);

The forms of verification certificate under (3), (4), (5) and (5) shall be attach strictly on a weighing and measuring instrument in the manner that if such sticker is to be detached, such sticker must be torn apart or destroyed or lost the original condition and cannot be used again and the size shall be as deemed appropriate to the size of a weighing and measuring instruments.

**Clause 4.** Verification certificate issued by a competent official and a license holder under section 41 of the Weights and Measures Act B.E. 2542 in accordance with the form annexed to the Ministerial Regulation on prescription of measuring device under the Weights and Measures Act B.E. 2542, type, characteristics, details of the material produced, maximum permissible error and verification of a weighing and measuring instrument, and rules and procedures for registration of a private mark B.E. 2546 shall continue to be in force until its expiration.
