Statute of the Ministry of Commerce Paying bribes, rewards and operating expenses By the Weights and Measures Act B.E.2542 (second edition) B.E.2559

As the Ministry of Commerce issued a regulation of the Ministry of Commerce. By paying bribes, rewards and operating expenses. According to the Weights and Measures Act B.E. 2542 (1999) B.E.2557 (2012).

For the performance of the Weight and Measures Act B.E. 2542 (1999) is accurate comply with the administrative structure of the division within the new provincial commercial office (One Roof). And adjusting the positioning system according to Civil Service Act B.E. 2551 (2008) and to comply with the regulation of the Ministry of Finance on the deduction of fines before the warehouse (second edition) B.E.2547 (2004). Regulation of the Ministry of Finance on the type and rate of fine before the warehouse dated 11 February B.E.2547 (2004). Minister of Commerce the regulation are as follows:

Clause 1 This Statute is called the "Statute of Ministry of Commerce By paying bribes rewards and operating expenses under the Weights and Measures Act B.E.2542 (1999) (second edition) B.E.2559 (2016)."

Clause 2 This statute shall enter into force from 2 October B.E.2559 (2016) onwards.

Clause 3 Repealed clause 4 "Mulct" of statue of the Ministry of Commerce by paying bibes reward and operating expenses under the Weights and Measures Act B.E.2452 (1999), B.E.2547 (2004) dated 27 July B.E.2547 (2004). And use the Following instead.

"Clause 4 This statute

"Must" means money paid by the Department of Internal Trade or the Office of the Permanent Secretary of the Ministry of Commerce. Or fines received pursuant to a court judgment of the Weights and Measures Act B.E. 2542 (1999)"

Clause 4 Repealed Clause 18 of the Ministry of Commerce regulation on the payment of bribes, award and operating expenses under the Weights and Measures Act B.E.2542 (19999), B.E.2547 (2004) dated 27 July B.E.2547 (2004). And use the following instead.

"Clause 18 The bribe paid to the leader of the arrest. Because of that notification the captive must not be the catcher or the person responsible for carrying out the law in that regard and the leader must notify the recipient of the following

- (1) General Directorate, Competent Officiar or Weights and Measurement Inspector that holds a special level of expertise under Department of Internal Trade.
- (2) Head of Weighing Centers, Head of Branch Office, Provincial Commerce Office the Permanent Secretary for Commerce, Competent Officiar or Weights and measurement Inspector that holds a special level of expertise perform duties in the Weighing Center or Branch Weight and Measure Office in Department of Internal Trade.

The leader may not notify the receiver of the notification under paragraph one. Because the captors must arrest the perpetrator by urgently. If the offender can escape, the offender may escape. The leader shall notify arrestee and the arrestee of the report of the arrest and sent the details of the receipt of the notification to the receiver of the notification under paragraph one"

Clause 5 clause 25 of the Regulation of the Ministry of Commerce shall be repealed. By paying bribes, award and operating expenses under the Weights and Measures Act B.E.2542 (1999), B.E.2547 (2004). And use the following instead.

"Clause 25 The leader or the catcher shall file a bribe application or prize money to the following person. Within one year from the date the case reaches itsend.

(1) General Directorate, Competent Officiar or Weights and Measurement Inspector that holds a special level of expertise under Department of Internal Trade in Ministry of Commerce. In case of catch leader or the captors are domiciled in Bangkok.

(2) Head of Weighing Centers, Head of Branch Office, Provincial Commerce Office the Permanent Secretary for Commerce in Ministry of Commerce. In case of captives or captive domiciled in other provinces.
