## Notification of the Department of Internal Trade

Regarding Prescription on Form of Mark to Prohibit to Use Measurement Gauge

-----

In order to bring about orderliness, correctness and appropriateness regarding the prescription of the mark to prohibit to use the measurement gauge by the weights and measures inspector in a case where he/she has found that the measurement gauge are improper, or the accuracy of the gauge exceeds contingency rate as prescribed.

By virtue of paragraph four of Section 57 of the Measurement Act, B.E. 2542 (1999), as amended by the Measurement Act (No. 3), B.E. 2557 (2014), the Director-General of the Department of Internal Trade has therefore issued this Notification, as follows.

**Article 1.** This Notification shall come into force upon the expiration of ninety days from the date of its publication in the Government Gazette.<sup>1</sup>

Article 2. The mark to prohibit to use the measurement gauge consists of a prohibiting card strung with copper wire and impressed by the Central Bureau's squeezing pliers having grooves of both sides on the lead seal in order that embossed alphabets ซิตว will appear on one side and the Thai serial number of the Central Bureau's squeezing pliers will appear on another side.

The prohibiting card under paragraph one shall be a creamy-brown card paper together with red printed statements. The prohibiting card and the usage of squeezing pliers shall comply with specified forms as attached to this Notification.

In a case where there is not enough space in the prohibiting card to fill out statements, another prohibiting card (next card) is required. The prohibiting card (next card) shall be a white card paper and in accordance with specified forms as attached to this Notification.

The mark to prohibit to use the measurement gauge under paragraph one shall have to ban the use of such gauge forever, except for destroying the said mark to prohibit to use the measurement gauge.

Article 3. It shall be deemed that the following marks are those to prohibit to use the measurement gauge under this Notification. All marks to prohibit to use the measurement gauge have been made by the weights and measures inspector prior to the date of enforcement of this Notification, in a case where he/she has found that the measurement gauge is improper, or the accuracy of the gauge exceeds contingency rate as prescribed under paragraph one of Section 57 of the Measurement Act, B.E. 2542 (1999), and the measurement gauge is still under the period of repair or the measurement gauge is still under the period of repair or the measurement gauge is still under the period of checking by competent officials for granting new certification.
