Regarding Form for Declaration Pursuant to Notification of the Central Committee
on the Price of Goods and Services

Whereas the Central Committee on the Price of Goods and Services has issued the Notification of the Central Committee on the Price of Goods and Services, No. 1, B.E. 2562 (2019) regarding Determination of Goods and Services under Control dated 22 January B.E. 2562 (2019) and the Notification of the Central Committee on the Price of Goods and Services regarding the stipulation of measures requiring business operators to declare the price, the remuneration, the capital cost, the expense, the importation plan, and the following detail : goods, the quantity and the storage place of toilet paper, tissue paper, corrugated cardboard, Kraft paper, printing and writing paper, garlic imported from foreign countries, liquefied petroleum gas filled in a container (LPG), licensing the right for publicizing the copyright work relative to a song for the commercial purpose, animal feed corn, wheat, barley to be used as animal feed raw material imported from foreign countries, sweetened condensed artificial cream, condensed milk, recombined milk, filled milk, water pump, powder milk, palm oil, chemical fertilizer, cement, wheat flour, detergent, liquid detergent, shampoo, fabric softener, dishwashing product, soap, liquid soap, oil palm seed, liquefied edible milk products, sanitary napkin, tapioca chip, para rubber, motorcycle tire, automobile tire, pesticides or fungicides, rice combine harvester, motorcycle, passenger car, truck, tractor, electrical wire, structural steel, flat sheet, rebar, pre-cooked food packaged in sealed container, and food packaged in hermetically sealed container, pursuant to the form as prescribed by the Secretary-General of the Central Committee on the Price of Goods and Services.
