## MINISTERIAL REGULATION

ON PRESCRIPTION OF FEES RELATING TO BUSINESS OPERATION OF WEIGHTS AND MEASURES AND FEE FOR INSPECTION OF WEIGHING AND MEASURING INSTRUMENTS OUTSIDE OF A COMPETENT OFFICIAL B.E. 2560

By virtue of section 5 paragraph one of the Weights and Measures Act B.E. 2542 amended by the Weights and Measures (No. 3) B.E. 2557 and section **38** of the Weights and Measures B.E. 2542, the Minister of Commerce hereby issues the Ministerial Regulations as follows:

**Clause 1.** This Ministerial Regulation shall come into force upon the expiration of thirty days from the date of its publication in the Government Gazette.

Clause 2. The followings shall be repealed:

(1) Ministerial Regulation No. 2 (B.E. 2544) issued under the Weights and Measures Act B.E. 2542;

(2) Minister Regulation No. 3 (B.E. 2547) issued under the Weights and Measures Act B.E. 2542.

**Clause 3.** Fee in issuing the Business Operation Certificate shall be collected as follows:

**Clause 5.** The fee for issuance of license for a manufacturer to be authorized inspector and self verification for repaired and manufactured weighing and measuring instruments is 5,000 Baht annually.

**Clause 6.** The fee for issuance of license for a repairer to be authorized inspector and self verification for repaired and manufactured weighing and measuring instruments is 1,000 Baht annually.

**Clause 7.** The fee for issuance of license renewal shall be in accordance with the fee of issuance of license.

**Clause 8.** The fee for substitute of business operation certificate shall be 100 Baht each.

Clause 9. The fee for issuance of substitute of license shall be 100 Baht each.

**Clause 10.** The fee for initial verification and inspection for non-automatic weighing instrument shall be under the following rates:

**Clause 23.** The fee for inspection and initial verification collected from a manufacturer in the case where the manufacturer is a licensee under section 41 shall be fifty percent of the fee for inspection and initial verification under clause 10, clause 11, clause 12, clause 13, clause 14, clause 15, clause 16, clause 17, clause 18, clause 19, clause 20 and clause 21.

**Clause 24.** The fee for inspection and subsequent verification collected from a repairer in the case where the repairer is a licensee under section 41 shall be twenty five percent of the fee for inspection and initial verification under clause 10, clause 11, clause 12, clause 13, clause 14, clause 15, clause 16, clause 17, clause 18, clause 19, clause 20 and clause 21.

**Clause 25.** The fee for inspection and verification without the issuance of verification shall be in accordance with the following rates:

- in respect of inspection for the initial verification, fifty percent of the fee for inspection and initial verification;
- (2) In respect of inspection for the subsequent verification, fifty percent of the fee for inspection and subsequent verification;

in the case of inspection for accuracy under (e), (f) or (g) by using different products, the fee shall equal the amount of products times the rate of fee per instrument but upon calculating together it shall not exceed 40,000 Baht per instrument.

**Clause 28.** The fee for a person requesting to have a competent official to inspect and verify a weighing and measuring instrument outside of the Central Bureau or Branch Bureau shall be in accordance with the following rates:

(1) in the case of official days and hours:

per day

- (a) for a competent official who is a civil servant in the position of general operation in the level of practitioner
   or the academic position in the level of practitioner
   each 300 Baht
- (b) for a competent official who is a civil servant in the position of
  - general operation in the level of professional
  - or the academic position in the level of professional

and above each 500 Baht per day in the case of working over the official working hours, the fee shall be double.

- (2) In the case of working outside the official hours:
  - (a) for a competent official who is a civil servant in the position of general operation in the level of practitioner

or the academic position in the level of practitioner each 400 Baht per day

- (b) for a competent official who is a civil servant in the position of general operation in the level of professional
   or the academic position in the level of professional
   and above
   each 600 Baht per day
- (3) in the case of working on official day off:
  - (a) for a competent official who is a civil servant in the position of general operation in the level of practitioner
     or the academic position in the level of practitioner
     each 600 Baht
     per day
  - (b) for a competent official who is a civil servant in the position of general operation in the level of professional or the academic position in the level of professional and above
     each 1,000 Baht per day
