Clause 6. Manufacturers or repairers of shelves fitted to pegs whose rated capacity is 20 Metric ton Must provide or construct a laboratory or facility. With accessories Required for To check and certify the machine with the following characteristics.

(1) is a laboratory or facility where the condition is stable, safe and secure; To be in accordance with the layout plan and the application to the Director General. And located in the area where there is transportation. To come with me The location of the central office or branch office.

(2) have a working environment Reasonable enough Will keep weight heavy weight. Total not less than 10 metric tons and used to install a hand-held machine for checking the quality of the machine. Manufactured or repaired.

(3) sufficient lighting system.

(4) There is equipment used to produce or repair a stationary platform attached to a stationary position. It is currently 20 metric tons, which is necessary and sufficient.

Clause 7. The Director-General of Internal Trade shall be in charge of this regulation.
