Notification

Re: The Local Employees to the Weights and Measures Personnel Appointment

B.E. 2552

In order to the decentralization action plan to provide local governments assigned a mission to transfer a weights and measures Personnel to the Local Administrative Organization.

By virtue of Section 5 under the Weights and Measures Act B.E. 2542 which contains certain provisions in relation to the restriction of rights and liberty of a person, in respect of Section 29, whereby in conjunction with Section 32 Section 33 Section 41 and Section 43 of the Constitution of the Kingdom of Thailand so permitted by the virtue of law, therefore, the Minister of Commerce hereby issues the Notification as follows.

Clause 1 This Notification shall come into force on the following day of publication in Royal Thai Government Gazette.

Clause 2 Bangkok officials qualified following an Inspector of Weights and Measures. Check duty spring scales in the local authority has a duty of care and responsibility for the Bangkok city. The mission was to transfer the Weights and Measures Act, plans and procedures for the Local Administrative Organization B.E. 2542

- (1) As the incumbent since 3 level or above. Which is equivalent to the civil service positions in general. Since work up technician level or position of academic. Since the operating level or above, which was assigned by the Bangkok Governor.
- (2) As a trained inspector Weights and Measures Program of the Department of Internal Trade Ministry of Commerce.

Clause 3 Pattaya officials qualified following an Inspector of Weights and Measures. Check duty spring scales in the local authority has a duty of care and responsibility for the Pattaya city. The mission was to transfer the Weights and Measures Act, plans and procedures for the Local Administrative Organization B.E. 2542

- (1) As the incumbent since 3 level or above. Which is equivalent to the civil service positions in general. Since work up technician level or position of academic. Since the operating level or above, which was assigned by the Pattaya Governor.
- (2) As a trained inspector Weights and Measures Program of the Department of Internal Trade Ministry of Commerce.

Clause 4 Local government qualified following an Inspector of Weights and Measures. Check duty spring scales in the local authority has a duty of care and responsibility for the operation of the municipality. The mission was to transfer the Weights and Measures Act, plans and procedures for the Local Administrative Organization B.E. 2542

- (1) As the incumbent since 3 level or above. Which is equivalent to the civil service positions in general. Since work up technician level or position of academic. Since the operating level or above, which was commissioned by the mayor of the municipal jurisdiction of municipal employees.
- (2) As a trained inspector Weights and Measures Program of the Department of Internal Trade Ministry of Commerce.

Clause 5 District employees qualified following an Inspector of Weights and Measures. Check duty spring scales in the local authority has a duty of care and responsibility for the operation of the district. The mission was to transfer the Weights and Measures Act, plans and procedures for the Local Administrative Organization B.E. 2542

- (1) As the incumbent since 3 level or above. Which is equivalent to the civil service positions in general. Since work up technician level or position of academic. Since the operating level or above, which was commissioned by the Chief Executive of the sub district Administrative jurisdiction of the district.
- (2) As a trained inspector Weights and Measures Program of the Department of Internal Trade Ministry of Commerce.
