Central Bureau of Weights and Measures With the mass transit

B.E.2542

According to the Weighing Scale Act BE 2542, the weighing scale is divided into the first level. Second floor And the third floor Which the Ministry of Commerce. Has issued the Ministry of Commerce Notification on the First Class Mass Measurement Act Weighing Scale Measure BE 2542 2012 dated February 10, 2012 and the Department of Trade has announced the Central Bureau of Weights. The story of the second-class section of the mass 500 kg. According to the Weighing Scale Act, BE 2542 (2012) dated 11 October 2012, the Central Bureau of Weights and Measures The 500 kg Class Three Weight Class is prescribed by the Weighing Scale Act, 1999. 2012, dated 12 November 2012 and 2 and 3, 2013, 7th January 2013, and 6th February 2013. Respectively, and announced the Central Bureau of Weights. Class 2 masses from 1 mg to 20 kg are prescribed in accordance with the Measurement Scales Act, BE 2542 (2014), dated 12 February 2014.

To provide mass storage retention. Meets the standards International Organization Of Legal Metrology Set in International Recommendation OIMLR 111-1 By virtue of Section 6 (1) of the Measurement Scale Act, BE 2542, the Director General of the Department of Internal Trade hereby issues the following regulations:

Clause 1 of this regulation is called. "Central Bureau of Weights and Measures With the mass transit 2542"

Clause 2. This regulation shall come into force from the day following the announcement date.

Clause 3. The Bureau of Supervision and Inspection of Scales shall have the duty of preserving the first-class, The third-order class of mass is to be as accurate as International organization of Legal Metrology prescriptive International Recommendation OIML R 111-1 Keep it in a mass lab, which is a safe place. And the calibration of the first class mass Second Class Mass Way And the third-tier mass transit model for a specified period.

Clause 4. The Northern Weights Center Northeastern Weighing Center The Eastern weighing center and the Southern weighing center are responsible for maintaining. Second Class Mass Way And the third-tier mass-based model. To be as good as International organization of Legal Metrology prescriptive International Recommendation OIML R 111-1 Keep it in a mass lab, which is a safe place. And the calibration of the first class mass Second Class Mass Way And the third-tier mass transit model for a specified period.

Clause 5. The branch office shall have the duty of maintaining the third-class mass standard as to the accuracy as prescribed. International organization of Legal Metrology prescriptive International Recommendation OIML R 111-1 Keep it in a mass lab, which is a safe place.

Clause 6. The persons who have the duties under Clause 3, Article 4, and Article 5, shall register the mass-registration according to the end of this regulation. And serial number serial number according to the method set forth as follows.

(1) Mass serial number serial number. Contains numbers and signs.

(A) the serial number of the class means the classification number of the standardized mass scale of the Central Bureau of Weights. Weighing centers and branch offices are as follows:

1 refers to a mass-scale class.

2 refers to the second-tier

3 refers to the third tier

(B) The number of the office shall be the number of the weighing center or branch office, which shall issue a serial number in the form of a mass statute, as specified in the first paragraph of the order of the Central Bureau of Weights and Measures. No. 1/2013, dated June 25, 2013, defining the method for issuing the serial number of the weighing instrument, except for the Central Office of Measurement.

(C) Sort numbers should be numbered from 0001 to the end of the year in which the serial number of the mass index is used. Use the new serial number for the following year.

(D) the last two digits of the year BE shall be used for the last two digits of the year BE issued by the serial number of the mass statute.

Make use of (-) or the dash between the serial number, the office number, the ordinal number, and the two-digit number of the year, respectively.

(2) the next calibration, use the old mass serial number routine.

(3) in the case of a mass scale in the same package or container; Issue the same mass number as the series of masses, specifying the minimum weight to the maximum weight.

(4) To affix or display the serial number of a mass statute on the basis of each mass of the competent authority, the calibration shall be readable. Clear and difficult to remove, except for the mass statistic series. Stamp or display mass serial number on the same container or container.

Clause 7. The Director-General of the Internal Trade Department shall be in charge of this regulation.
