MINISTERIAL REGULATION

RE: PRESCRIPTION OF VERIFICATION MARK OF WEIGHTS AND MEASURES INSTRUMENTS

B.E. 2560 (2017)

By virtue of section 5 paragraph one and section 30 paragraph four of the Weights and Measures Act B.E. 2542 as amended by the Weights and Measures Act (No. 3) B.E. 2547, the Minister of Commerce hereby issues the Ministerial Regulation as follows:

Clause 1. Clause 85 and Clause 86 of the Ministerial Regulation prescribing measuring instrument under the Weights and Measures Act B.E. 2542, type, characteristics, details of the materials used for production, maximum permissible error and verification of weighing and measuring instruments and rules and procedures of registration of private mark B.E. 2546.

Clause 2. Verification mark of Central Bureau or Branch Bureau shall be in accordance with the following forms:

- (1) in the case of verification provision by a competent official under section 30 or verification provision by a government agency, state agency, state organization or state owned enterprise under section 31 shall use a verification mark as the outside of the garuda in accordance with the form *chor wor* 1001 annexed with this Ministerial Regulation;
- (2) in the case where it is the verification of a licensee under section 41, a symbol used shall be the letter "Chorwor" in accordance with the form chor wor 1002 annexed with this Ministerial Regulation.

Clause 3. The verification mark under clause 2 consists of 4 types as follows:

(1) the nail stamp type: it shall be made in embossed badge when being

affixed on a weight and measure instrument and making a mark of the verification mark;

(2) forceps type: one side is the verification mark while the other side is

numbers for the forceps of the Central Bureau. It shall be made in groove when affixing on the

verification mark of a weight and measure instrument, an embossed badge of a verification

mark and number will be created;

(3) attachment type: it shall be made in sealing strip attached on a weight

and measure instrument in the manner that if it is detached, it must be torn or damaged or lost

its condition and cannot be used again;

(4) sandblast type: it shall be fretted as the verification mark for sandblast

through the fret and making a picture of verification mark on a weight and measure instrument.

A verification mark under paragraph one shall be in a size appropriate to the size

of a weight and measure instrument.
