

RULE OF THE CENTRAL BUREAU OF WEIGHTS AND MEASURES

ON PERMISSION TO BE A PERSON OBTAINING LICENSE TO PRODUCE WEIGHING AND MEASURING INSTRUMENTS B.E. 2539 (1996)

For permission, obtaining license for producing weighing machine, volume measuring tool, measurer shall be appropriate, precise and conform, the Rule of the Department of Commerce Registration and Orders of the Bureau of Weight and Measure which are contradictory to this Rule shall be repealed and the rules on permission to be a person obtaining prospecting license to produce weighing machine, volume measuring tool, measurer under section 15 of the Weights and Measures Act B.E. 2466 as follows:

1. Qualifications of a person applying for license:

1.1 having a domicile in Thailand ;

1.2 in the case of natural person, such person shall reach his legal age and in the case of juristic person, an evidence illustrating the status of juristic person with the purpose of producing any of the followings: weighing machine, volume measuring tool, measurer;

1.3 not being sentenced or having his case being considered on the ground of commission of an offence under the law on measurement gauge;

2. business operation:

2.1 business operation place shall contain at least 100 square meter which a person applying for prospecting license shall have the ownership right or have the right to use such place;

2.2 in regard to submission of application for prospecting license, in the case where a business operation place is situated in a province, it shall be submitted at the provincial commercial registration office or district/provincial weight and measure office responsible for such district/province;

3. equipments and tolls required in the business operation:

a person producing measuring gauge shall have:

3.1 standard measuring gauge for comparing the accuracy of measuring gauge and shall compare the accuracy regularly under the prescribed time period;

3.2 necessary mechanical tools for producing measuring gauge;

4. capital for business operation for no less than 500,000 Baht;

5. no less than five workers including skilled craftsman shall work for a person applying for license;

6. when a license to produce, order, fix or sell weighing machine, volume measuring tool or measurer is damaged or lost, evidence of reporting such loss to an investigator or annex of a license or a copy of damaged license shall be submitted to the Weight and Measure Bureau or provincial commercial registration office or weight and measure subsidiary office;

7. in regard to submission of a copy of license of a subsidiary office, name and address of subsidiary office shall be appeared in the certificate of juristic person or commercial registration certificate, as the case may be;

8. in respect of application for license to produce weighing machine, volume measuring tool, measurer, the provincial commercial registration or weighing and measuring instruments subsidiary office, it shall be submitted together with documents to the Weight and Measure Bureau prior to the submission to Central Bureau for consideration;

9. A person applying for license shall submit an application in accordance with the official form and submit other evidence in accordance with the table as annexed including the application.
