**Memorandum of Agreement for Filing Application for Permission
via the Electronic System of Transport**

Clause 1 The controlled goods which I have an intention to file the application are.....goods as follows:

- (1) garlic imported from foreign countries
- (2) unmilled rice, rice
- (3) animal feed corn
- (4) wheat to be used as animal-feed raw material imported from foreign countries
- (5) barley to be used as animal-feed raw material imported from foreign countries

Clause 2 I well understand and acknowledge the way of practice in respect of the Regulation of the Office of the Central Committee on the Price of Goods and Services regarding Rules and Procedures in relation to Filing Application for Permission via Electronic System of Application for Permission for Transport of Controlled Goods and the manual of using the electronic system of transport, and I agree to abide by the aforesaid way of practice in all respects.

Clause 3 I have had an electronic certificate issued by a service provider who is in charge of the issuance of such certificate (Certification Authority : CA), and certified that the certificate is valid pursuant to the law governing electronic transactions.

Clause 4 I have had electronic equipment that is used for taking a photograph which can specify a location and for sending the information of such a photograph into the electronic system of transport as set up by the Office of the Central Committee on the Price of Goods and Services, the Department of Internal Trade.

Clause 5 The information which is accessed to the electronic system of transport and my action which is related to the application for permission for transport and the transport of controlled goods via the electronic system of transport as set up by the Office of the Central Committee on the Price of Goods and Services shall be deemed as the information sent by and the action taken by (Mr./Mrs./Ms./a company/ a partnership/an owner of business)

And I certify the correctness and completion of such information and the aforesaid action which is related to the application for permission for transport and the transport of controlled goods in all respects. The information can be cited as evidence in the legal proceedings in spite of such information being in the electronic form.
