Remark: 1. In declaring the information of goods in each item, it is required to fill out only the item which is required to declare under the Notification.

- 2. In a case where there is not enough space to fill out information, the next page is required.
- 3. For a column "Distribution Price", a producer, a hirer for production, an importer into the Kingdom for distribution, a pack dividing operator is required to declare the price at a factory and the wholesale price of distribution, except for a case of a direct distribution to a consumer, it is required to declare the retail price of distribution, in case of a sole distribution, it is required to declare the wholesale price of distribution and the retail price of distribution.
- 4. In declaring the reduction, it is required to clearly specify the reduction or the condition on giving the reduction to each purchaser.
