Instructions

Reporting

- (1) Person responsible for the drafting of this report is rice trading permit recipient of international rice export, international rice import, rice milling, rice broker, wholesale and rice trading place types.
- (2) Person responsible for making this report in (1) is required to submit his monthly rice trading report by the seventh day of each subsequent month. Rice trading permit recipient with main office in Bangkok Metropolis shall submit his report to the Department of Internal Trade, while rice trading permit recipient with main office located in other province shall submit his report to the provincial commercial office of his respective locality.
- (3) This report can be submitted in person, by registered mail, facsimile or electronic data system. Accordingly, the Competent Officer will deem the date of affixing of the daily stamp at the original postal office or the receipt date of the facsimile as the date of expression of intention to report. As for reporting by electronic data system, the date when the electronic data is entered into the data system of the Department of Internal Trade shall be deemed the date of expression of intention to report.
