- Remark :**
1. In case of being the first time of declaration, it is not required to fill out information in a column "Old".
 2. In case of notifying the change in the declared list or the declared price, it is required to fill out information in both columns "Old" and "New".
 3. In declaring the information of goods in each item, it is required to fill out only the item which is required to declare under the Notification.
 4. In a case where there is not enough space to fill out information, the next page is required.
 5. For a column Distribution Price, a producer or an importer into the Kingdom for distribution is required to declare the price at a factory and the wholesale price of distribution, except for a case of a direct distribution to a consumer, it is required to declare the retail price of distribution, in case of a sole distributor, it is required to declare the wholesale price of distribution and the retail price of distribution.
 6. In declaring the reduction, it is required to clearly specify the reduction or the condition on giving the reduction to each purchaser.
