Instructions

In reporting

(1) Persons who are required to make this report are the persons who have received the letters of permission for operating rice trading in the type of trading by exporting rice to a foreign country, in the type of importing rice from a foreign country, in the type of milling rice, in the type of wholesale trade and in the type of rice port.

(2) Persons who are required to make the report under (1) shall submit the monthly report on the rice trading within the seventh day of the following month.

The person who has received the letter of permission for operating rice trading, having the head office located in the area of Krung Thep Maha Nakhon, shall submit the report at the Department of Internal Trade

The person who has received the letter of permission for operating rice trading, having the head office located in other province, shall submit the report at the Provincial Commercial Office in such area.

(3) The submission of this report shall be made by oneself, sent by a registered and replied mail or facsimile or the electronic data system.

A competent official shall deem that the date when there is a daily seal stamped at the origin post office or the date when the facsimile is received is the date of announcing intention of notifying.

In the case of notifying via the electronic data system, the date when the electronic data enters into the data system of the Department of Internal Trade, the Ministry of Commerce shall be deemed as the date of announcing intention of notifying.
