Conditions (1) The Letter for Controlling Transport shall be returned to the Provincial Commercial Office of the area or the Office of the Central Committee on the Price of Goods and Services, the Department of Internal Trade, within 7 days as from the time of the transport arriving at the destination or to be sent by the registered and replied mail, whereby the date when there is a daily seal affixed at the post office shall be deemed as the date of delivery.

(2) In case of no transport, this Letter for Controlling Transport shall be returned within 3 days as from the date of its expiry.

(3) This Letter for Controlling Transport is deemed as the Letter of Permission under the Notification of the Central Committee on the Price of Goods and Services Regarding Control of Transport and Arrangement of Account for Controlling Rice in State's Stock in which the Committee on Rice Policy and Management Has Approved to Release to Industry.

(4) It is required to transport according to the quantity/duration as specified in the Letter for Controlling Transport only.

(5) If the applicant fails to do so or the specified period of time is over, he/she shall be liable to imprisonment for a term not exceeding 5 years or for a fine not exceeding 100,000 Baht, or both.
