Warning (1) This Letter of Permission is an original as printed from the electronic system of transport as set up by the Office of the Central Committee on the Price of Goods and Services, the Department of Internal Trade. It is prohibited from revising or adding contents in this Letter of Permission. (2) This Letter of Permission shall be applicable for the transport pursuant to the date, the time and the place of destination which are specified only. (3) The applicant for permission has a duty to deliver the original Letter of Permission which has already been recorded the receipt of goods or which has already been informed the cause of a failure to receive the goods, as the case may be, via the electronic system of transport within 48 hours as from the time of the recording of receiving the goods or the time of informing the cause of a failure to receive the goods, as the case may be. In this regard, the delivery shall be complete when the applicant delivers the original Letter of Permission to a competent official in person or by the registered and replied mail at the governmental office which is the destination of the transport. If the applicant fails to deliver or delivers over the specified period of time, he/she shall be liable to imprisonment for a term not exceeding 5 years or for a fine not exceeding 100,000 Baht, or both.
