9. Total of sales quantity of the requesters	<p>- Indicate total sales quantity of goods/services under the conduct of agreeing which the requesters sell. Please indicate quantities of sale in the past three years and estimation of total quantity after the conduct of agreeing for the current year (in case when the agreement is undertaken during the year) and the next year.</p> <p>Total of sale quantity means all of the sales quantity of goods/services under the conduct of agreeing, for instance, if the requester submits the request for a conduct of agreeing with another business operator, to designate customers whom another business operator will not sell goods/services in competition (under No. 8). However, the total sales quantity, for which the requesters designate customers, accounts for only 60% of the total sales quantity. The notification under No. 9 will be the notification of all information.</p>
